

ORDER GRANTING THE JOINT MOTION FOR FINAL APPROVAL OF CLASS SETTLEMENT

THIS MATTER, having been opened to the court by, JONES, WOLF & KAPASI, LLC; GREENBERG DAUBER EPSTEIN & TUCKER, PC; and DE PIERRO RADDING, LLC, the attorneys for all parties in this matter, appearing to certify the proposed class pursuant to R. 4:32-1 via a Joint Motion for Final Approval of Class Settlement; approving the proposed Settlement Agreement; appointing Plaintiff as representative of the class; appointing Plaintiff's attorneys Joseph K. Jones, Esq., of JONES, WOLF & KAPASI, LLC as class counsel; and the Court having reviewed the moving papers, and the Court having heard the argument of counsel, if any; and for good cause having been shown;

ORDERED, that

- 1. The Joint Motion for Final Approval of Class Settlement is granted.
- 2. Certifying the proposed Class for settlement purposes pursuant to R. 4:32-1 consisting of:

Any and all New Jersey citizens and business entities operating in New Jersey who were presented with a proposal, document, form, contract and/or agreement between May 8, 2007 through April 7, 2017 which proposal, document, form, contract and/or agreement provided for the consumer's or business entity's checks to be converted to electronic debits or ACH transfers or other type of transfer of funds by Electronic Payment Systems, Inc., which proposal, document, form, contract and/or agreement actually, purportedly or may have violated in any respect any and all federal or state statutes, and/or federal or state regulations, including but not limited to the Retail Installment Sales Act, N.J.S.A. 17:156C-1 et seq., and/or the Truth-in-Consumer Contract Warranty Notice Act, N.J.S.A. 56:12-13 et seq., and/or the Consumer Fraud Act, N.J.S.A. 56:8-1 et seq., and/or the New Jersey Administrative Code, N.J.A.C. 13:45A-26C et seq., and/or the New Jersey common law.

- 3. Approving the proposed Settlement Agreement annexed to the Certification of Joseph K. Jones, Esq., as Exhibit A.
- 4. Appointing Plaintiff as class representative.
- 5. Appointing Plaintiff's attorneys, Joseph K. Jones, Esq., as class counsel.
- 6. Approving the incentive award of \$3,500 to the named Plaintiff, Pamela Stokes.
- 7. Approving the award of attorney's fees and costs in the amount of \$30,000 to Jones, Wolf & Kapasi, LLC.
